PRIVACY POLICY

1. Application

Vibe Studios understands that your privacy is important to you. This notice outlines how your Personal Information will be protected. By using the services of Vibe Studios or visiting its website you agree to the terms of this Privacy Policy. 2. Definitions

- 2.1 In this Policy:
 - (a) "Vibe Studios" refers to Vibe Studios Pty Ltd (ACN 162 082 064);
 - (b) "Services" refers to services offered by Vibe Studios, including but not limited to classes relating to dance, performances, concerts, and other related services;
 - (c) "Personal Information" is defined as "any information or an opinion (including information or an opinion forming part of a database), whether true or not, and whether recorded in a material form or not, about an individual whose identity is apparent, or can reasonably be ascertained, from the information or opinion". Such information may include your name, phone, mail, email and other information you choose to provide or required for the purposes of dealing with Vibe Studios as a student, parent or guardian of a student, customer, potential customer, supplier, job applicant, stakeholder, contractor or in some other capacity which may identify you but expressly excludes photographs; and
 - (d) "Website" refers to Vibe Studios' website, www.vibe.org.au.

3. How will Personal Information be collected

- 3.1 Vibe Studios may collect Personal Information directly from you, including your name, address, contact number and email when you:
 - (a) contact us by phone, mail, email or visit our Website;
 - (b) make an enquiry about a Service;
 - (c) use the Service;
 - (d) enter any competition or special offer.
- 3.2 Your Personal Information may also be collected by Vibe Studios from publicly available sources or third parties.
- 3.3 Should you provide Vibe Studios with Personal Information about another person (other than a minor), you must obtain their consent and let them know about this policy, prior to giving their information.

4. How your Personal Information may be used

- 4.1 Vibe Studios' use of Personal Information will be limited to:
- (a) answering your questions and providing you with information regarding the Services;
- (b) processing transactions for the supply of the Services as requested by you, including but not limited to enrolment forms, direct debit forms and remittance advices;
- (c) offering you Services of Vibe Studios which may be of interest to you, unless you advise that you do not wish to

- receive such further marketing (refer to opt out option below);
- (d) meeting our legal obligations;
- (e) managing and resolving any complaints and issues;
- (f) carrying out internal administrative functions;
- (g) market research; and
- (h) other purposes with your consent, whether written, verbal or implied.
- 4.2 Vibe Studios will not use or authorise the use of your Personal Information for any purpose other than as set out above or for any other purpose made known to you at the time of collection of your Personal Information.
- 4.3 If your phone number is registered on the "Do Not Call Register" (or similar), by providing Vibe Studios with your phone number, you consent to receiving phone calls from Vibe Studios and acknowledge and agree that such calls will not constitute unsolicited telemarketing calls.
- 4.4 Your Personal Information will not be shared, sold or disclosed for any other purpose.

5. Opt out

6. Disclosure of your Personal Information

- 6.1 Vibe Studios will only disclose your Personal Information to a third party in the following circumstances:
 - (a) to your representative with your consent, which may be given in writing, verbal or implied from your conduct or as nominated by you as your executor, trustee or legal representative. We will take reasonable steps to ensure that your representative undertakes to protect your privacy; and/or
 - (b) to our accountants and legal advisors, information technology service provider, payment systems operator, financial institution, law enforcement agency.

7. Protection of your Personal Information

- 7.1 Personal Information collected by Vibe Studios will be stored by Vibe Studios in hardcopy and/or electronic form. Vibe Studios takes reasonable measures to keep all Personal Information secure and protected from interference, misuse or loss and from unauthorised access, modification or disclosure and will be restricted to persons properly authorised.
- 7.2 If Vibe Studios determines that your Personal Information is no longer needed for the particular purpose it was collected, Vibe Studios will take reasonable steps to destroy or permanently de-identify that Personal Information.

8. Access to your Personal Information

This information may include your Personal Information as well as non-personal data such as the server address, domain name, date and time of visiting the Website, pages accessed, previous site you visited, whether you have visited our Website previously and the type of webbrowser used.
- 9.3 Vibe Studios is not responsible for the contents or practices of any links to third party websites which are provided on our Website and does not endorse such websites.
